## TERMS & CONDITIONS

1. Endzone Sports Charities (ESC) will examine only Denver Broncos game-used jerseys. ESC reserves the right not to examine any item submitted.
2. Submissions sent to ESC must be packaged so as to reasonably ensure that damage will be prevented during shipping. A copy of this completed submission form should be placed inside the shipping container before sealing and a duplicate copy should be kept for your records. The sealed package should be sent to ESC at the address shown at the top of this form via insured common carrier such as US Postal Service, UPS, FedEx, etc. ESC shall bear no liability whatsoever for any damage to any submission shipped or delivered to ESC or any loss incurred in transit to or from our facility.
3. Donation and fees are paid to ESC when items are received and are non-refundable.
4. ESC will make all efforts to examine and return submissions within a reasonable time frame. However, ESC assumes no responsibility for damages relating to failure to certify and return submissions within a specific time frame.
5. ESC will typically process and ship item(s) within 5-10 business days of receiving the submission at our facility. Please await your return shipment for results. No examination results will be disseminated in any manner except via receipt of items.
6. ESC makes all reasonable attempts to ensure the item's care while in our possession. However, if ESC determines a submission was lost or damaged while in our possession, the customer will be compensated according to ESC's standard procedures, not according to the customer's assigned insurance value of the item(s) submitted.
7. Customers must inspect all returned items immediately upon receipt and report any damage or discrepancy to the item or description to ESC within three (3) days of receipt.
8. Examination involves individual judgments that are, to some extent, subjective, and require the use of professional opinions. These opinions can change over time.
9. Any controversies or claims arising out of submissions to ESC will be adjudicated in the courts of Pueblo County, Colorado. In addition to other relief deemed appropriate by the court, the prevailing party shall be remunerated for its attorney's fees and other costs of litigation, even if that stipulation is not directly provided for by the statute.
